# International Conference on “Connecting Voices to Combat Corruption”

## OVERVIEW

*India ranks 76 out of 168 countries in the Corruption Perception Index for the year 2015 , as per the Transparency International report, with a score of 38 for corruption in public sector undertakings on a scale of 0 (highly corrupt ) and 100 (very clean).*

*Corruption is a considerable obstacle to economic and social development around the world. It has a negative impact on sustainable development. However, it remains widespread in the country and there have been many instances of political, bureaucratic corruption, corporate frauds, public funds embezzlement, fraudulent procurement practices and judicial corruption. The government has put in place a well developed legal and institutional framework, with institutions including the Central Bureau of Investigation, the Office of the Comptroller and the Auditor General, and the Central Vigilance Commission. The Supreme Court has taken a firm stance against corruption in recent years and made several important rulings. Another achievement has been the enactment of the Right to Information (RTI) Act in 2005, which grants citizens access to government information and a mechanism to control public spending. In spite of this progress, the law enforcement and reforms have a long way to go.*

*Particularly in businesses, it is found that corruption can obstruct growth, increase costs, and pose serious legal and reputational risks. Companies should work against corruption in all its forms, including extortion and bribery. All companies need to have robust anti-corruption measures and practices to protect their reputations and the interests of their stakeholders.*

*India, being looked upon as a “bright spot” in the global economic arena, cannot afford to have corruption and lack of governance pulling down its potential. There is an urgent need to fight corruption and improve transparency, Governance and integrity at all levels.*

*Keeping this background in the mind, Governance Regulation Anti Corruption through Education (GRATE), The Madras Chamber of Commerce & Industry (MCCI), Anti Corruption Academy of India (ACA), New Delhi and Institute of Directors (IOD) have joined hands to organize an International Conference on “Connecting Voices to Combat Corruption ” on 23rd April 2016 at Hotel ITC Grand Chola, Chennai.*
